**MANAGEMENT'S DISCUSSION AND ANALYSIS**

This management's discussion and analysis ("MD&A") of financial condition and results of operations of Golconda Gold Ltd. ("Golconda" or the "Company"), was prepared by management as at August 27, 2025. Throughout this MD&A, unless otherwise specified, "Golconda", "the Company", "we", "us" or "our" refer to Golconda Gold Ltd. and its subsidiaries and should be read in conjunction with the unaudited condensed interim consolidated financial statements and notes thereto for the three and six months ended June 30, 2025 and June 30, 2024 (the "Interim Financial Report"), as well as the audited consolidated financial statements and notes thereto for the years ended December 31, 2024 and December 31, 2023 (the "Annual Financial Statements").

The Annual Financial Statements have been prepared by management in accordance with International Financial Reporting Standards ("IFRS") issued by the International Accounting Standards Board ("IASB"). The Interim Financial Report has been prepared by management in accordance with IFRS applicable to interim financial reporting, including IAS 34, *Interim Financial Reporting*. All amounts are expressed in U.S. dollars unless otherwise noted. Other information contained in this document has also been prepared by management and is consistent with the data contained in the Annual Financial Statements.

The Company's certifying officers are responsible for ensuring that the Interim Financial Report and MD&A do not contain any untrue statements of a material fact or omit to state a material fact required to be stated or that is necessary to make a statement not misleading in light of the circumstances under which it was made. **CORPORATE OVERVIEW**

The Company's principal business activities are the exploration for, development of, and operation of gold mining properties. The Company operates through its wholly-owned subsidiary, Galane Gold Mines Ltd., two assets: (a) a producing gold mine which also has the rights to certain mineral exploration tenements (the mine and mineral exploration tenements collectively, the "Galaxy Property", which hosts various ore bodies, including the Galaxy and Princeton ore bodies that are currently being mined) located in the Republic of South Africa through subsidiaries located in South Africa; and (b) a gold and silver mine and processing infrastructure located in the United States of America (the "Summit Property") that is currently in care and maintenance while a restart plan and financing is finalised. The common shares in the capital of the Company (the "common shares") have been listed for trading on the TSX Venture Exchange (the "TSXV") in Canada under the symbol "GG" since September 6, 2011 and trade on the OTCQB in the United States under the trading symbol "GGGOF".

**OUTLOOK**

The Company continues to execute the Galaxy Property development plan, which is expected to result in an increased annual production over the next three years to 27,000 payable ounces of gold through the addition of new mining equipment and additional face workings to utilize the spare capacity in Galaxy's existing 50,000 tonnes per month ball mill circuit. The ramp-up of production at the Galaxy Property continues with a 3% increase in gold production in Q2 2025 compared to Q1 2025 and a 90% increase compared to Q2 2024. Princeton Top started to deliver ore at the end of Q2 2025 and is expected to position Galaxy to continue the ramp up of production throughout the remainder of the year. The increased production and record gold price has enabled the Company to pay down borrowings and invest further in new mining equipment at Galaxy.

In respect of the Summit Property, the Company continues to work with potential financing providers and off-take partners, with several indicative term-sheets received to date, to put in place a non-dilutive financing package to facilitate the re-start of operations at the Summit Property as soon as possible. In Q2 2025, the Company retained the services of a project manager for the Summit Property, who has significant experience in mining in New Mexico. The Company is working on a re-start plan for Summit, which the Company aims to put back into production during the second quarter of 2026.

The Company continued to mine from the Princeton deposit, including Princeton Top, and Galaxy deposit during Q2 2025.

- Princeton – In Q2 2025, the Company continued mining in the PS5 and PS19 ore bodies with 12,346 tonnes (including 2,828 tonnes from Princeton Top) at 4.63 g/t being mined, 141% more tonnes than Q2 2024 and at a 22% higher grade. 20,818 ore tonnes at 4.17 g/t have been mined in YTD 2025 compared to 7,445 tonnes at 3.82 g/t in YTD 2024.
- Galaxy – In Q2 2025, the Company continued mining the Galaxy deposit with 19,135 tonnes at 3.06 g/t being mined, an increase of 66% on Q2 2024 tonnes and at a 14% higher grade. 38,034 tonnes at 3.26 g/t have been mined in YTD 2025 compared to 22,670 tonnes at 2.97 g/t in YTD 2024.

In Q2 2025, the Company produced 2,480 tonnes of concentrate, an increase of 64% over Q2 2024, at a grade of 38.0 g/t containing 3,030 ounces of gold, an increase of 1,439 ounces (90%) from Q2 2024.

YTD 2025, the Company produced 4,761 tonnes of concentrate, an increase of 82% over YTD 2024, at a grade of 39.0 g/t containing 5,977 ounces of gold, an increase of 2,879 ounces (93%) from YTD 2024.

Revenue for Q2 2025 was \$7.7 million which is \$4.7 million higher than Q2 2024 and was generated from the sale of 3,073 provisional contained ounces of gold (2,452 payable ounces of gold) at a realised gold price of \$3,254 / payable oz (\$2,597 / contained oz). Revenue for YTD 2025 was \$14.3 million which is \$9.1 million higher than revenue for YTD 2024 and was generated from the sale of 5,990 contained ounces of gold (4,776 payable ounces of gold) at a realised gold price of \$3,047 / payable oz (\$2,430 / contained oz).

Earnings from mining operations was \$3.5 million for Q2 2025 compared to income of \$0.3 million in Q2 2024. The significant increase in earnings from mining operations in Q2 2025 is predominantly due to increased mining volumes, gold sales and associated revenues, along with a higher realized gold price, partially offset by increased operating costs due to increased mining and processing volumes, and general cost inflation. Earnings from mining operations of \$6.3 million for YTD 2025 compares to income of \$0.5 million for YTD 2024, with the variance predominantly driven by increased revenues, partially offset by increased operating costs in YTD 2025.

Corporate general and administrative costs were \$471,000 in Q2 2025 compared to \$560,000 in Q2 2024 and \$972,000 YTD 2025 compared to \$1.05 million in YTD 2024. Some technical consulting costs were reallocated to mine operating costs in Q2 2025 and YTD 2025 which mainly drove the variance relative to the comparative periods.

Share-based compensation was \$145,000 in Q2 2025 and \$362,000 in YTD 2025 due to the issuance of 460,000 stock options and 4,860,000 DSUs in Q1 2025, with the fair value of the awards being expensed over the vesting period of the awards. There were no awards vesting in Q2 2024 or YTD 2024 and hence no charge.

The foreign exchange loss of \$33,000 for Q2 2025 and \$170,000 YTD 2025 was predominantly driven by a strengthening of the South African Rand against the U.S. Dollar during the quarter and year to date.

Finance expenses of \$362,000 in Q2 2025 were \$59,000 lower than Q2 2024 due to lower overall loans and borrowings balances. Financing expenses totaled \$737,000 YTD 2025, an increase of \$61,000 compared to YTD 2024 due to inclusion of the significant financing component associated with the deferred revenue for a full six months in YTD 2025 compared to only four months in YTD 2024.

Other financing expense was \$35,000 for Q2 2025 compared to \$41,000 in Q2 2024. These expenses represent the accretion charge on the Company's restoration and rehabilitation provision. Other financing expense of \$71,000 for YTD 2025 compared to other financing expense of \$81,000 in YTD 2024.

Other expenses of \$91,000 for Q2 2025 and \$111,000 for YTD 2025 represent costs associated with the Summit Property that have been expensed. These have increased compared to Q2 2024 and YTD 2024 as the Company prepares to move towards a re-start of the Summit Property. YTD 2024 other expenses of \$381,000 included \$324,000 of transaction costs incurred on the Streaming Agreement (defined below) which were non-recurring.

Current assets at June 30, 2025 increased by \$1.8 million compared to December 31, 2024 predominantly due to an increase in cash of \$0.8 million, an increase of \$0.8 million in trade receivables due to increased gold production and the timing of gold sales at quarter end, and an increase of \$0.3 million in advance deposits associated with the purchase of new mining equipment, partially offset by a decrease in net taxes recoverable due to repayments of \$0.2 million of VAT.

Current liabilities at June 30, 2025 increased by \$0.7 million compared to December 31, 2024 predominantly due to the reclassification of the Dantisor loan note of \$1.9 million from non-current to current liabilities, offset by the repayment of \$1.8 million of the Ocean Partners credit facility. Accounts payable and accrued liabilities increased by \$0.5 million compared to December 31, 2024 due to deferred payment terms on new mining equipment purchased in YTD 2025 totaling \$0.9 million and the increase in South African Rand denominated accounts payable due to foreign exchange, offset by the pay-down of accounts payable at Galaxy.

Non-current assets at June 30, 2025 increased by \$1.8 million compared to December 31, 2024 due to additions to plant and equipment of \$1.6 million and capitalized development of \$0.9 million, offset by depreciation and depletion of \$0.7 million.

Non-current liabilities decreased by \$1.4 million compared to December 31, 2024 predominantly due to reclassification of the Dantisor loan note noted above.

Total shareholders' equity as at June 30, 2025 increased by \$4.2 million compared to December 31, 2024 due to the net earnings recorded for YTD 2025.

#### **LIQUIDITY, CAPITAL RESOURCES AND GOING CONCERN**

The Company defines capital as consisting of shareholders' equity, being made up of issued capital stock, contributed surplus and deficit and long-term debt. The Company's objectives when managing capital are primarily to support the creation of shareholder value, but also to ensure that the Company is able to meet its financial obligations as they become due. The Company has not declared or paid any dividends on its common shares.

In order to fund the business activities intended in its current business plan, the Company entered the \$5 million Stream Agreement in February 2024, the proceeds of which were used to invest in mining equipment and underground development at the Galaxy Property. As described above under "Summary of Financial Position", at June 30, 2025, the Company had a working capital deficiency of \$3.7 million and had positive operating cash flow of \$5.2 million for YTD 2025.

The Company's officers and senior management take full responsibility for managing the Company's capital and do so through regular review of financial information and cashflow forecasting. The Board of Directors is responsible for overseeing this process.

***Going Concern***

The Interim Financial Report was prepared using IFRS that are applicable to a going concern.

As at June 30, 2025, the Company had a working capital deficiency (current assets less current liabilities) of \$3.7 million (December 2024: \$4.8 million). Earnings from mining operations were \$6.3 million for the six months ended June 30, 2025 and cash flow generated from operating activities was \$5.2 million for the six months ended June 30, 2025.

The Board of Directors of the Company has performed an assessment of the ability of the Company to continue as a going concern which covers a period of at least 12 months from the date of approval of the unaudited condensed consolidated interim financial statements. Risks to the Company's ability to continue as a going concern include the ability of operations to meet production targets to generate sufficient cash flow to manage working capital and to repay borrowings upon maturity. Because of these uncertainties, there can be no assurance that the measures that management is taking to mitigate risks to the Company's liquidity position will be successful. The current commodity price and exchange rate environment can be volatile, which may have an impact on the Company's cash flows and the Company continues to review its near-term operating plans and to take steps to reduce costs and maximize cash flow generated from operations.

The Company is subject to various commitments under the Streaming Agreement. If the Company is in breach of such commitments, the counterparty to the Streaming Agreement has various potential recourses under the agreement including calling for the repayment of the \$5,000,000 initial deposit. The Company has obtained a waiver for certain commitments and has entered discussions with respect to potential amendments to certain terms of the Streaming Agreement. However, in a downside scenario in which the Company is unsuccessful in obtaining such amendments to the Streaming Agreement or extensions to the waiver, it would be necessary for the Company to raise additional funding if the deposit under the Streaming Agreement was called for repayment. The Board of Directors believes that additional funding would be available to the Company in such scenario on reasonable terms and in the required time frame.

As a result of above, a material uncertainty exists that may cast significant doubt on the ability of the Company to continue as a going concern. Therefore, the Company may be unable to realise its asset and discharge its liabilities in the normal course of business.

The Board of Directors believes that the Company is a going concern due to the strong operating cash flow generated by mining operations, the significant flexibility the Company has on both operating and capital expenditure and the likelihood that additional financing would be readily available should the Company require it.

These unaudited condensed interim consolidated financial statements do not reflect adjustments to the carrying values of the assets and liabilities, the reported revenues and expenses, and the balance sheet classifications used, that would be necessary if the Company were unable to realize its assets and settle its liabilities as a going concern in the normal course of operations. Such adjustments could be material.

**FINANCIAL INSTRUMENTS**

The Company's financial instruments consist of cash, trade and other receivables, accounts payable and accrued liabilities, and loans and borrowing. The fair value of the Company's trade and other receivables, and accounts payable and accrued liabilities approximate their carrying value. The Company's other financial instruments, specifically loans and borrowings are recorded at amortized cost using the effective interest rate method.

Credit risk is the risk that one party to a financial instrument will cause a loss for the other party by failing to discharge an obligation. The Company is subject to normal industry credit risks. The credit risk related to the trade receivable is considered minimal as gold and gold concentrate is sold to creditworthy offtake partners and settled promptly, usually within the following six to eight weeks and the other receivable balance consists of amounts outstanding on tax credits from governmental authorities, each of which are expected to be paid in the near term at face value. Management believes that the Company's exposure to credit risk is minimal.

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The Company's approach to managing liquidity risk is to try to ensure that it will have sufficient liquidity to meet liabilities when due. See the "Liquidity and Capital Resources" section in this MD&A for further commentary on the Company's liquidity risks.

Currency risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in foreign exchange rates. The Company's operations are in South Africa, the U.S.A. and Canada and its presentation currency is U.S. dollars. The international nature of the Company's operations results in foreign exchange risk as transactions are denominated in foreign currencies, including the South African Rand and Canadian Dollars. The operating results and the financial position of the Company are reported in U.S. dollars. The fluctuations of the operating currencies in relation to the U.S. dollar will, consequently, have an impact upon the reported results of the Company and may also affect the value of the Company's assets and liabilities. The Company monitors the volatility of foreign exchange rates and will hedge its currency risk if it determines that the need arises.

Interest risk is the risk that the fair value of future cash flows will fluctuate as a result of changes in market risk. The Company monitors the volatility of interest rates and will hedge its interest risk if it determines that the need arises.

Market risk is the risk that the fair values of financial instruments or that the Company's future cash flows will fluctuate because of changes in market commodity rates. The Company's efforts are currently focused on the production of gold. As such, the Company's future cash flows and valuation of its mineral assets will be exposed to market risk on the price fluctuations of gold as a commodity.

#### **ISSUED AND OUTSTANDING SHARE CAPITAL**

The Company's authorized capital consists of an unlimited number of common shares, of which 71,840,033 common shares are issued and outstanding as of the date of this MD&A.

The Company has an omnibus equity incentive plan (the "Equity Incentive Plan"), pursuant to which officers, directors, employees and consultants are eligible to receive grants of stock options, DSUs, restricted share units, performance share units, and other share-based awards. The Equity Incentive Plan allows for (a) the grant of up to such number of stock options as is equal 10% of the total issued and outstanding common shares at the date of the grant and (b) the grant of other forms of equity incentive awards such that up to an aggregate maximum of 7,127,330 common shares may be issuable pursuant to those awards.

As of the date of this MD&A, subject to the terms of the Equity Incentive Plan, (a) options to purchase up to 843,652 common shares are outstanding and options to purchase up to 6,340,351 common shares are available for grant and (b) up to 5,532,633 common shares may be issued pursuant to outstanding DSUs and 1,027,973 common shares are available for grant pursuant to other non-option based forms of equity incentive awards.

As of the date of this MD&A, the Company has no outstanding warrants to purchase common shares.

#### **FINANCING ARRANGEMENTS**

##### ***Ocean Partners Offtake Agreement and Credit Facility***

On August 3, 2022, the Company entered into an agreement with Ocean Partners UK Limited ("Ocean Partners") which provided the Company with an unsecured \$3,000,000 short-term revolving credit facility bearing interest at US\$ 3-month LIBOR (or CME Term SOFR) plus 7.5% ("Ocean Partners Facility"). Once a drawdown under the Ocean Partners Facility is repaid, such amount can subsequently be redrawn. Interest and principal for the Ocean Partners Facility can be repaid against deliveries of gold concentrate valued at market rate or cash by the Company to Ocean Partners under the relevant agreement. The Company can elect to repay the full principal amount outstanding under the Ocean Partners Facility and any accrued interest without any penalty with two weeks of advance notice. During the year ended December 31, 2024 the interest on the Ocean Partners Facility increased to US\$ 3-month LIBOR (or CME Term SOFR) plus

9.5%. As at June 30, 2025, \$0.5 million of the Ocean Partners facility remained outstanding, which as at the date hereof had been fully repaid.

***Dantinator Loan Note***

On March 29, 2023 the Company entered into a loan agreement with Dantinator SA with respect to a term loan facility for \$1,000,000 with a maturity date of March 29, 2024. On March 27, 2024, the maturity date was extended to March 29, 2025 and on November 29, 2024 the maturity date was further extended to March 29, 2026. The loan bears an interest rate of 6% per annum and has a redemption premium of 100%. The loan is secured against all of the issued and outstanding shares of Summit Gold Corporation.

***Streaming Agreement***

On February 27, 2024, the Company entered a \$5,000,000 gold purchase and sale agreement (the "Streaming Agreement") with Empress Royalty Holding Corp. ("Empress") which provides that Galaxy Gold Reefs Ltd., the subsidiary of the Company which holds the Company's interest in Galaxy, will deliver 3.5% of payable gold production from the Galaxy mine at a cash purchase price of 20% of spot gold until 8,000 ounces have been delivered. Thereafter, 2% of payable gold production will be delivered from Galaxy at a cash purchase price of 20% of spot gold price, until the earlier of 20,000 ounces having been delivered or 20 years after the first gold delivery was made.

**TRANSACTIONS WITH RELATED PARTIES**

On August 13, 2020, the Company entered into a loan agreement with its former CEO (the "Former CEO"), who retired on November 30, 2024, as partial compensation for the services provided by the Former CEO in 2019. The loan is non-interest bearing, non-recourse, became due and payable on August 13, 2024, and has not been repaid. Pursuant to the terms of the loan agreement, the Former CEO used the proceeds of the loan to exercise 507,000 common share purchase warrants held by the Former CEO. A total of 243,671 common shares issued to the Former CEO on exercise of the warrants are currently held by the Company as security for the outstanding loan balance. The balance of the loan to the Former CEO as at June 30, 2025 was C\$60,918 (December 31, 2024 – C\$60,918).

**COMMITMENTS**

As at the date of this MD&A, the Company had commitments totaling approximately \$1.1 million for mining equipment at its Galaxy Property.

**OFF-BALANCE SHEET ARRANGEMENTS**

Other than the low value operating lease arrangements not recognized on the initial adoption of the revised IFRS 16 Leases, the Company currently has no off-balance sheet arrangements.

Under the terms of the purchase agreement for the Summit Property the Company has a contingent cash payment of \$8.2 million due to the vendor upon commencement of production at the mine.

**SUPPLEMENTAL INFORMATION TO MANAGEMENT'S DISCUSSION AND ANALYSIS**

***Cash Costs***

This MD&A refers to operating cash cost excluding royalties per ounce, which is a non-GAAP performance measure, in order to provide investors with information about measures used by management to monitor performance. Management uses this information to assess how well the producing gold mines are performing compared to plan and prior periods, and also to assess the overall effectiveness and efficiency of gold mining operations. Cash cost figures are calculated in accordance with a standard developed by the Gold Institute, which was a worldwide association of suppliers of gold and gold products and included leading North American gold producers. The Gold Institute ceased operations in 2002, but the standard is still an accepted standard of reporting cash costs of gold production in North America. Adoption of the standard is voluntary, and the cost measures presented herein may not be comparable to other similarly titled measures of other companies. Cash cost includes mine site operating costs such as mining, processing,

administration, but are exclusive of impairment, amortization, reclamation, and exploration and development costs. Operating cash cost is the total cash cost less those costs capitalized as attributable to the removal of excess waste in developing new resources. These costs are then divided by the Company's ounces of gold produced to arrive at the cash cost measures on a per ounce basis. These measures, along with sales, are considered to be key indicators of a company's ability to generate operating earnings and cash flow from its mining operations. These measures of cash costs do not have any standardized meaning prescribed by IFRS and differ from measures determined in accordance with IFRS. They are intended to provide additional information and should not be considered in isolation or as a substitute for measures of performance prepared in accordance with IFRS. These measures are not necessarily indicative of net earnings or cash flow from operations as determined under IFRS.

The following tables provide a reconciliation of cash cost measures for the mine to the mining costs excluding impairment, depreciation and amortization reflected in the Interim Financial Report.
